- Holding Period: 2 years
- Stock Certificate: 3 to 6 months
- Membership Card: Issued 1 week after approval
- Screening of Documents: 1 to 2 weeks
- Dependents' age limit: up to 25 years old; unmarried
- **Class A share:** Individual or Corporate with one (1) nominee
- **Class B share:** Corporate with two (2) nominees
- **Class C share:** Corporate with three (3) nominees
- **Class D share:** not for sale; includes the initial one (1) common share
- No discount on the fees for transfer of Corporate shares to the company owner's children
